INTERNET TELLER REMINDERS

Here are a few tips to keep in mind:

- 1. PENDING TRANSFERS- this screen only shows reocurring transfers that have been set up to happen automatically.
- 2. TRANFER FUNDS- when submitting a new transfer request, it will not show under "Pending <u>Transfers</u>" and will be completed the <u>next business</u> <u>day</u>. After selecting the SUBMIT button twice, a printable confirmation is displayed. This means your transfer was successful!
- 3. VIEWING TRANSFERS- once a transfer request is submitted and confirmed, you will not see the updated balances on your account until the next business day. When logging online, under the Welcome, "Your Name", will show when your account was updated for the day in the "Information As Of" date and time.
